

Farms to Pharms Dispensary Operations Overview

The dispensary will have bars on the inside of all exterior windows and will have glass break alarm sensors installed. The front glass double door will have a roll down gate open during all business hours. The doors will have a high-security deadbolt and will be wired to both a window break alarm and a door open alarm on each. This door will lead to the reception/waiting area. Patients will enter this area and have their doctor's recommendation verified by a receptionist sitting behind a bullet proof glass window. All visitors in this area will be required to submit to being screened by a metal detector and checked for weapons. This task will be performed by a licensed and bonded armed private security guard.

After being checked for weapons and providing the receptionist with the necessary documents (government issued ID and valid Doctors Medical Marijuana Recommendation) to be verified and recorded the security guard will assist the Patient or Caregiver to sign the Collective Agreement on a provided iPad. Once the Patient has joined the collective and has been properly verified they will be allowed to enter the first high security door of the ingress safety area. All doors in and out of the safety area will be heavy duty, high security steel, equipped with steel thresholds and 3,000 lbs. magnetic locking devices (referred to as "maglock"). The security area, is a preventative security measure to ensure only the people wanted are enabled to enter the main dispensing area and in the volume desired. The security area is set up so only one door can open at a time and prevents a group of people from running into the facility all at once. The controls for these doors will be setup with one switch at the reception desk and a

second behind the counter in the main dispensing area, also by numeric keypads mounted on the wall beside each door. Only security guards and management will have codes to these doors. There will be two "all door open" buttons that will disengage all the maglocks in the building (therefore allowing all doors to open at once) in the event of a fire or other type of emergency. The second door of the entrance security area will only open after the first door has closed and vice versa. If a group of patients come to the facility together only a maximum of two patients in any particular group will be allowed into the main dispensary area at one time. This protocol helps to prevent any type of attempted burglary. Additionally, a maximum of twelve patients will be allowed in the main dispensing area at any one time. The patients in the dispensing area will be required to form a que by use of retractable crowd control barriers (similar to those used at banks). The patients in the que can browse the menu while they wait to see the herbal consultant (sales person). Once the patient has chosen medicine and provided reimbursement for the products selected they will be directed to the egress security area. This egress security area will have an EXIT button on the wall next to the door. To exit, one will be required to depress the EXIT button which will release the maglock and allow them entry to the egress security area. Once the first door closes behind them, the patient will push a button next to the second door to release the maglock on the second door and they will be back in the reception area. They can proceed to exit the facility, or wait for the rest of their party to complete their selections and join them. The egress security area will have reinforced walls to prevent one from breaking through them in the event of an attempted robbery. This separate ingress, egress security area system has proven efficient to prevent any attempts of robbery at other locations.

Further emergency protocols will be discussed with the Stockton Police Department.

All internal doors in the facility will be heavy duty steel and equipped with 3000lbs. maglocks. The rear door to the facility will only be used in the event of an emergency. A silent alarm switch will be installed in multiple locations to call the police if ever needed. The safe room will have reinforced walls and door. Only upper management will have access to the safe room by way of high security deadbolt and maglock with keypad. All doors in the entry/reception area will have high security deadbolts that will be locked at closing to further prevent one from breaking into the facility after hours.

A state of the art security camera system will be used with off-site data storage. At least one uniformed armed licensed security guard will be onsite during all business hours. After hour security patrols will check on the facility throughout the night and will respond to any alarms.

Items dispensed

Farms to Pharms sources only locally grown, pesticide and mold free cannabis products. All products are tested for quality and potency, to ensure patient safety. Some products come pre-packaged, others are weighed in front of patients by staff.

Typically the cannabis flowers will be weighed by hand in front of patients as well as most forms of concentrates. We stock up to seventy ailment specific varieties of cannabis flower. These different strains provide therapeutic relief for individual needs. Research has proven that CBD rich strains provide many benefits without any intoxicating effects. Patients require these strains for debilitating ailments where many other treatments have proven to be ineffective. We stock many CBD rich strains as well as typical Sativa, Indica, and hybrid strains of cannabis flowers and concentrates. Various forms of concentrates or "Hash" will be stocked such as wax, crumble, shatter, full melt, bubble hash, and kief among others. These different forms of concentrates will each come in many different varieties or "Strains". Most of these products will be weighed in front of patients but some will also come pre packaged. All vaporizer pens, cartridges, and medicated edibles come prepackaged only.

Other items dispensed include topical creams, oils, salves, lotions and soaps. Prepackaged edibles range from snacks to drinks, jerky, capsules, cookies, candies, and various other medicated infused cannabis products.

There will be absolutely no cultivation, production or manufacturing of any type of edible or concentrate at this facility.
