STOCKTON CITY COUNCIL

RESOLUTION APPOINTING GARRETT DANIELLS, RANIA GEORGIES, JOSEPH MARGOLIES, AND ANNE WILCOX TO THE STOCKTON ARTS COMMISSION, SETTING COMMISSIONER TERMS TO CREATE STAGGERED VACANCIES, REAFFIRMING THE PROCESS BY WHICH ARTS COMMISSIONERS ARE SELECTED, AND FINDING AGREEMENT BY THE MAYOR AND COUNCIL REGARDING CURRENT RECOMMENDATIONS OF THE STOCKTON ARTS COMMISSION

The Stockton Arts Commission acts in an advisory capacity to the Stockton City Council in connection with the artistic and cultural development of the City; and

The Stockton Arts Commission promotes and encourages programs that further the development and public awareness of all the arts including public art, fine arts, and performing arts; and

The Stockton Arts Commission recommends the appointment of Garrett Daniells, Rania Georgies, Joseph Margolies, and Anne Wilcox to the Commission; and

The Community Services Department recommends setting the terms of these appointments to expire on December 31, 2020, in accordance with Stockton Municipal Code section 2.04.040.B.1, which permits the City to institute terms of less than four years when necessary to create staggered vacancies; and

In accordance with Stockton Municipal Code section 2.94.040.A members of the Stockton Arts Commission are appointed by the Mayor with approval of the City Council; and

There is a longstanding tradition of the Stockton Arts Commission assisting in the appointment of new members by selecting and interviewing applicants in conjunction with the City Clerk's office and in accordance with existing City Council policies and municipal code; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The City Council appoints Garrett Daniells, Rania Georgies, Joseph Margolies, and Anne Wilcox to the Stockton Arts Commission for a three-year term to commence immediately upon approval and ending on December 31, 2020.

2. To create staggered terms the City Council sets the appointment of the Commissioners to a three-year term ending on December 31, 2020.

3. The City Council reaffirms that the Stockton Arts Commission shall continue to assist the Mayor in the appointment of new commissioners by interviewing, in conjunction with the City Clerk's office and in accordance with existing City Council policies and the Stockton Municipal Code, and to assist in the recommendation of qualified applicants.

4. The Mayor with approval of the City Council agrees with the current recommendations of the Stockton Arts Commission and the Community Services Department.

5. The City Manager is authorized to take whatever actions are necessary and appropriate to carry out the purpose and intent of this Resolution.
