- 6.1 Discuss roles and responsibilities of Commissioners and Staff

- 6.2 Recommendation to Community Services for expenditure of Strong Communities funding
  - City staff has said that the City Council would like to see a SAC Strategic Plan that will include youth programs. The \$50,000 will remain available even if not spent in the current fiscal year.
- 6.3 Gift Committee recommendation for Fire Fighter's Memorial
  - The Gift Committee has recommended the Stockton FireFighter's Relief Association request to relocate the Firefighters Memorial to Fire Station #6 in Victory Park.

Resolution: It was moved and seconded by Commissioners McMillan and Vincent, respectively, and passed unanimously, to approve the Gift Committee recommendation for the relocation of the Firefighters Memorial to Fire Station #6 in Victory Park.

#### VII STANDING COMMITTEE REPORTS

- 7.1 Governance Committee Lafferty
  - Governance Committee met last month and reviewed the agenda packet for November SAC meeting, Roles and Responsibilities of Commissioners and Staff, and Arts Awards News Release.
  - The Nominating Committee will conduct interviews using the current applications on hand. Staff will contact the applicants and arrange the interview location, date, and time.
- 7.2 Grants Committee Lafferty
  - Commissioner Lee presented the Grants Workshop report; she suggested that a
    member of the Commission be present during the workshop to assist and act as a
    gatekeeper. Also, it was recommended that the attendance policy regarding late
    comers should be defined in the grant guidelines. All residents of Stockton, regardless
    of their status in life, can apply for the SAC grant.
  - Commissioner Lee has agreed to be the co-chair of the Grants Committee.
- 7.3 Arts Awards Committee (AAC) Liwanag-Eichele
  - 2018 Arts Awards News Release and nomination packet were posted on City website.
  - Next AAC is meeting is scheduled for Saturday, November 11, 2017, at 9 a.m. at Duck Nook Restaurant.
  - There was a general discussion about STARlight Awards whether to continue having
    it on a quarterly basis or not. Staff suggested having it annually and inviting previous
    and current grant recipients to showcase their art project/event to a larger audience.
    At the same time, the Arts Awards Committee can give out STARlight awards to the
    honorees. AAC will take the suggestion and discuss it further at their next meeting on
    Saturday, November 11, 2017.

- Thornton Road project the foundation has been started.
- Grants Program PAC will continue to work on the grants draft guidelines.
- Victory Park Community Outreach meeting Staff will work on the draft for Request For Qualification (RFQ).
