### NOTIFICATION :

On 03/21/2018 at 1800 hours I, Officer [REDACTED] conducted follow-up on this report.

### INVESTIGATION :

On the morning of 02/14/2018 I detained SUB [REDACTED] for public intoxication. [REDACTED] was extremely intoxicated and refused commands to disperse. I hand cuffed her and placed her in Officer [REDACTED] car; [REDACTED] booked [REDACTED] into San Joaquin County Jail for public intoxication.

It later became known [REDACTED] 19 years old.

Today (03/21/2018) I went to [REDACTED] house to speak with her about that night. [REDACTED] was not home but I called her. [REDACTED] stated the following in summary:

### STATEMENT OF (SUB) [REDACTED]

[REDACTED] 19 years old. On the night of 02/14/2018 [REDACTED] went to the Ave with 3 other friends after "pre-gaming" (drinking alcohol prior to arriving at a location that sells alcohol).

[REDACTED] was highly intoxicated by the time they reached the Ave; they arrived at approximately mid-night.

At the front door of the Ave was a bouncer, he asked [REDACTED] if she was 21. [REDACTED] told the bouncer she was and went inside.

Once inside the Ave, [REDACTED] thinks she had just 2 drinks from the bar. The first drink her brother paid for, a "Sex on the Beach" (a vodka mixed drink). The second drink she does not remember how she got due to her high level of intoxication but recalls it being an "Adios Mother Fucker" (a mixed vodka, gin, rum, tequila, curacao drink).
