RESOLUTION APPROVING THE NOTICE OF EXEMPTION NO. CE015-17, APPROVING THE PLANS AND SPECIFICATIONS, AND AWARDING A CONSTRUCTION CONTRACT FOR THE TRAFFIC SIGNAL AND SAFETY LIGHTING MODIFICATIONS AT THE INTERSECTIONS OF PACIFIC AVENUE/CASTLE STREET AND HAMMER LANE/KELLEY DRIVE, PROJECT NO. PW9934/PW1529

On January 11, 2018, the City Clerk of the City of Stockton opened, examined, and publicly declared the sealed proposals or bids offered for the Traffic Signal and Safety Lighting Modifications at the Intersections of Pacific Avenue/Castle Street and Hammer Lane/Kelley Drive, Project No. PW9934/PW1529; and

The project will upgrade the existing traffic signals at the intersections of Pacific Avenue at Castle Street, and Hammer Lane at Kelley Drive. The project will upgrade these signals to include protected left-turn signal phasing, wheelchair ramps, monitoring cameras, emergency vehicle pre-emption, pedestrian count down displays, and Accessible Pedestrian Signals; and

Tim Paxin's Pacific Excavation, Inc. is the apparent low bidder in the amount of \$405,832 and its bid is regular in all respects; and

The funding for this contract will be encumbered as follows: PW1529 – Traffic Signal Modification (082-3020-640.20-62) \$400,832; PW1529 – Traffic Signal Modification (447-7989-670.20-62) \$5,000 for a total of \$405,832; and

The project is in conformance with the City's General Plan, pursuant to Government Code section 65402 and is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) as specified under Article 19, Section 15301, Class 1, of the CEQA Guidelines, because this is a discretionary project under the City's jurisdiction and qualifies as a project which has been determined to not have a significant effect on the environment; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The City Manager is authorized to approve the filing of Notice of Exemption No. CE015-17 under CEQA for the Traffic Signal and Safety Lighting Modifications at the Intersections of Pacific Avenue/Castle Street and Hammer Lane/Kelley Drive, Project No. PW9934/PW1529, a copy of which is attached as Exhibit 1 and incorporated by this reference.

2. The City Council approves the plans and specifications for the Traffic Signal and Safety Lighting Modifications at the Intersections of Pacific Avenue/Castle Street and Hammer Lane/Kelley Drive, Project No. PW9934/PW1529.

3. A Construction Contract between the City of Stockton and Tim Paxin's Pacific Excavation, Inc., in the amount of \$405,832, is hereby awarded, and the City Manager is authorized and directed to execute same, a copy of which is attached as Exhibit 2 and incorporated by this reference.

4. The City Manager is hereby authorized to take whatever actions are necessary and appropriate to carry out the purpose and intent of this Resolution.
