**BALLOT MEASURE:** Shall the measure pursuant to which (i) the City of Stockton shall incur an indebtedness and issue bonds in the maximum aggregate principal amount of not to exceed \$15,000,000 (excluding bonds described in Section 53364.2(e) of the California Government Code) with interest at a rate or rates not to exceed the maximum interest rate permitted by law at the time of sale of such bonds on behalf of the Community Facilities District No. 2018-2 (Westlake Villages II) (the "CFD") Improvement Area 1, the proceeds of which bonds will be used to acquire and/or construct certain facilities and pay for the costs of issuing the bonds and related expenses; (ii) a special tax payable solely from lands within Improvement Area 1 of the CFD shall be levied annually, commencing in the City's fiscal year 2018-19, upon lands within the Improvement Area 1 of the CFD to pay for the principal and interest upon such bonds, to pay the costs of the City in administering the Improvement Area 1 of the CFD, and to pay for the costs of acquiring and/or constructing certain facilities; and (iii) the annual appropriations limit of Improvement Area 1 of the CFD shall be established in the amount of \$1,300,000 **be adopted?**
