 - c. Approving the Rezoning of a 2.11-acre portion of the overall 10.09-acre site from RH (Residential, High-Density) to CG (Commercial, General); and
 - d. Approving an amendment to the Eight Mile Road Precise Road Plan to allow a 30-foot wide right-in and right-out driveway; and
 - e. Approving the Design Review for the project to ensure compliance with all applicable provisions of the City's Design Review Guidelines.
 - f. Allowing a convenience store selling a combination of alcohol, gasoline, and general merchandise with car wash facility and two additional commercial buildings at the southeast corner of Eight Mile Road and Thornton Road, in accordance with the findings of fact detailed herein.
