RESOLUTION DECLARING ELECTION RESULTS OF THE CITY OF STOCKTON PRIMARY MUNICIPAL ELECTION OF JUNE 5, 2018

A Primary Municipal Election was consolidated with the State of California Primary Election held on June 5, 2018, pursuant to Stockton City Charter Article VII; and

The San Joaquin County Registrar of Voters ("Registrar") was authorized to canvass the returns of the election pursuant to an agreement between the City of Stockton and the County of San Joaquin entered into on January 23, 2018; and

The Registrar has conducted the canvass and stated the results in the "Certificate of Results of the City of Stockton Municipal Election Held on June 5, 2018"; and

California Elections Code sections 10262, 10263, and 10264 require the adoption of a resolution reciting the fact of the election and a statement of the results; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The whole number of votes cast in the City of Stockton was 17,642 as confirmed by the Registrar.

2. The names of the persons voted for, the offices for which they were voted, and the total number of votes given in the City to each person are as set forth in the Certificate of Results prepared by the Registrar, dated September 4, 2018, attached hereto as Exhibit "1" and incorporated herein.

3. The number of votes given at each precinct to each person is as set forth in an excerpt from the Statement of Votes – Election Summary Report prepared by the Registrar, dated June 30, 2018, attached hereto as Exhibit "2" and incorporated herein.

4. SOL JOBRACK having received 56% of votes for the office of COUNCILMEMBER from DISTRICT 1, is hereby declared elected for said district for a four-year term commencing January 1, 2019, and ending December 31, 2022.

5. SUSAN LOFTHUS and PAUL CANEPA received the greatest number of votes for the office of COUNCILMEMBER from DISTRICT 3 and are hereby declared the candidates for said district who will proceed to a district only runoff at the General Municipal Election to be held November 6, 2018.

6. CHRISTINA FUGAZI and DYANE BURGOS MEDINA received the greatest number of votes for the office of COUNCILMEMBER from DISTRICT 5 and are hereby declared the candidates for said district who will proceed to a district only runoff at the General Municipal Election to be held November 6, 2018.
