- 3. The undersigned hereby consents to the levy of the assessments upon the abovementioned parcel(s) in said amount by action of the City Council of the City of Stockton following the close of the public hearing on November 6, 2018.
- 4. The undersigned expressly waive each of the following:
 - (a) any and all defects in notice or procedure in the conduct of the public hearing and the assessment ballot procedure, whether known or unknown;
 - (b) the entitlement to file any lawsuit or other proceeding to challenge any aspect of the proceedings of the City of Stockton relative to Stockton Consolidated Storm Drainage Maintenance Assessment District No. 2005-1 (City of Stockton, County of San Joaquin, California), including without limitation, the assessment ballot proceeding, the levy of the assessments, which entitlement would otherwise extend 30 days beyond levy of the assessments (presently scheduled to occur on November 6, 2018); and
