I am a fourth generation Stocktonian that went away for school and returned for family. I began my professional science training at Indiana University, Bloomington (B.S. Microbiology), continued graduate studies here in Stockton at the University of the Pacific (M.S. Biological Science/Physical and Life Science teaching credentials) and at the University of California, Davis (M.S. Hydrologic Science). I became involved with environmental issues specifically water quality and waste discharges after working for McCormick and Baxter Creosoting Company as a quality control chemist. I subsequently became a Registered Environmental Health Specialist and worked for San Joaquin County on contaminated site cleanups. I went back to school and earned a Master of Hydrologic Science degree from the University of California Davis from which I was recruited to work for a consulting firm. I found that I missed the teaching aspect of my graduate program. I began to use my teaching credentials that I earned many years before and have continued working in the field of education. I want to serve because I want to be part of the positive changes happening in Stockton, increasing public participation, and to represent various groups in the community including environmental and disadvantaged communities.

While in Sacramento, when opportunities arose to use my science skills outside of teaching, I took advantage and did consulting work if the project fit into my schedule. Since I have moved to Stockton and now that I am working at the School for Adults two evenings a week and a month during summer break, I have stopped pursuing those outside assignments. Nevertheless, I still very much enjoy the technical aspects of environmental project planning and implementation and have time to pursue those interests. After returning to Stockton I have returned to doing conservation work for the Sierra Club, Delta Sierra Group, as their Webmaster and Conservation Chair. I have been increasingly involved with groundwater planning in the Eastern San Joaquin Subbasin since the development of the Sustainable Groundwater Management Act in 2014 attending meetings, working with NGOs, and providing comments. I have attended many of the City of Stockton Water Advisory Group meetings. I am knowledgeable of the technical and regulatory issues that are associated with water and wastewater projects. I want to ask the questions that will help more of our residents understand these issues and get more involved. Good public outreach and involvement efforts are necessary to have a strong sense of community.
