RESOLUTION APPROVING THE NOTICE OF EXEMPTION NO. NOE19-19, APPROVING THE PLANS AND SPECIFICATIONS, AND AWARDED A CONSTRUCTION CONTRACT FOR THE INSTALL GUARDRAILS (16 LOCATIONS), PROJECT NO. PW1714/FEDERAL PROJECT NO. HSIPL-5008(168)

On December 19, 2019, the City Clerk of the City of Stockton opened, examined, and publicly declared the sealed proposals or bids offered for the Install Guardrails (16 Locations), Project No. PW1714/Federal Project No. HSIPL-5008(168); and

The project will enhance safety by installing guardrails at critical locations throughout the City. The project locations are situated along major arterial roadways primarily at railway and river bridge crossings, where the existing guardrails no longer meet current standards; and

Frank Medina is the apparent low bidder in the amount of \$862,196 and its bid is regular and responsible in all respects; and

Caltrans National Environmental Policy Act determination was received on May 6, 2019. The State determined that the project is a Categorical Exclusion under 23 CFR 771.117(c): activity (c)(21). Similarly, the project is in conformance with the City's General Plan, pursuant to California Government Code section 65402; and

The project is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) as specified under Article 19, section 15301(c), of the CEQA Guidelines, because this is a discretionary project under the City's jurisdiction and qualifies as a project which has been determined to not have a significant effect on the environment; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The City Council approves the filing of Notice of Exemption No. NOE19-19 under CEQA for the Install Guardrails (16 Locations), Project No. PW1714/Federal Project No. HSIPL-5008(168), a copy of which is attached as Exhibit 1 and incorporated by this reference.

2. The City Council approves the plans and specifications for the Install Guardrails (16 Locations), Project No. PW1714/Federal Project No. HSIPL-5008(168).

3. The City Council awards a Construction Contract between the City of Stockton and Frank Medina, in the amount of \$862,196, and the City Manager is authorized and directed to execute same, a copy of which is attached as Exhibit 2 and incorporated by this reference.

4. The City Manager is hereby authorized to take whatever actions are necessary and appropriate to carry out the purpose and intent of this Resolution.
