I. Getting our Fiscal House in Order

- At the close of Fiscal Year 2018-19, the General Fund working capital reserve was fully funded with reserves at 50 percent of the total reserve target, compared to 45 percent in the prior year
- Produced an on-time, structurally-balanced Budget along with the Budget in Brief, Capital Improvement Plan and Fee Schedule
- Identified \$3 million over budget estimates during the fourth quarter for Council to allocate to priorities
- Contributed \$14.5 million to the Section 115 trust for future pension costs
- Adopted revised Council policy requiring services and maintenance tax on all new greenfield residential development which created a Communities Facilities District to implement that policy
- Received authority from Council to move all utility accounts in the CalWater service area to owner-only billing
- Sent approximately \$1.2 million to the County for assessment to the property tax roll for delinquent utility charges
- Implemented Click2Gov for Accounts Receivable to allow customers to pay non-utility invoices online
- Cleared approximately 70 audit findings through the internal auditors
- Received Council approval to expand Bank of the West partnership to incorporate ePayables and PCard program, which is scheduled to implement in 2020
- Initiated two pilot programs for sole source and cooperative agreements to improve efficiency when acquiring exempt from bid goods and services
- Issued 2018-2019 Comprehensive Annual Financial Report on November 27, 2019, approximately a month earlier than last year
- Completed the 2018-2019 Audit with no findings, and issued the following financial statements in November 2019:
 - Measures M; W; Measure A Agreed Upon Procedures; Core Revenues Agreed Upon Procedures; and GANN Limit Agreed Upon Procedures.
- Refunded \$53 million in water bonds that created \$19.3 million in cashflow savings with a net present value of \$13.4 million
- Procured interim financing of \$118 million at 1.40% for the Regional Wastewater Control Facility
 Modifications project, essentially borrowing at less than the rate of inflation
- Issued approximately \$9 million in bonds to support the Cannery Park
- Submitted Water Infrastructure Finance and Innovation Act (WIFIA) application; the expected funding from WIFIA is \$108 million
- Completed the baseline Radio Fund Long-Range Financial Plan
- Closed the Van Buskirk Golf Course; Swenson Golf Course was transitioned from a third-party operator arrangement to a to a long-term lease

II. Increase Public Safety

- Non-fatal shootings and homicides, after a mid-year spike, have remained flat compared to a low in 2018
- A decrease in overall Uniform Crime Reporting, with violent crime decrease 0.9% and property crime 3.9%, and seized over 940 firearms
- Continued active recruitment and hiring to maintain a 3-5% vacancy rate within the Department
- Conducted 71,000 hours of in-house training
- Achieved a live release rate of 82% at the Animal Shelter
- Removed over 784,000 square feet of graffiti, 75,000 cubic feet of trash, and over 800 abandoned vehicles from private property
- Expanded Procedural Justice Training to key community stakeholders, including seven faithbased organizations trained in Implicit Bias alongside members of the Police Department
