RESOLUTION APPROVING THE NOTICE OF EXEMPTION NO. NOE23-20, APPROVING THE PLANS AND SPECIFICATIONS, AND AWARDING A CONSTRUCTION CONTRACT FOR THE SIDEWALK, CURB, AND GUTTER REPAIR PROGRAM FY 2019-20 SB1, PROJECT NO. PW1915

On June 11, 2020, the City Clerk of the City of Stockton opened, examined, and publicly declared the sealed proposals or bids offered for the Sidewalk, Curb, and Gutter Repair Program Fiscal Year (FY) 2019-20 SB1, Project No. PW1915; and

The project will remove and replace sidewalks curbs, and gutters damaged by Citymaintained tree roots at approximately 128 locations citywide; and

The project will also replace sidewalk at six locations along Harding Way, between Lincoln and El Dorado Streets; and

FBD Vanguard Construction, Inc. is the lowest responsive bidder in the amount of \$909,600 for the Base Bid, therefore the project is awarded to FBD Vanguard Construction, Inc. in the total amount of \$1,045,560 which also includes the Bid Alternate in the amount of \$135,960; and

The project is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) as specified under section 15301(c) (Existing Facilities), of the CEQA Guidelines, because this is a discretionary project under the City's jurisdiction and qualifies as project which has been determined to not have a significant effect on the environment; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

- 1. The City Council approves the filing of Notice of Exemption No. NOE23-20 under the CEQA for the Sidewalk, Curb, and Gutter Repair Program FY 2019-20 SB1, Project No. PW1915, a copy of which is attached as Exhibit 1 and incorporated by this reference.
- 2. The City Council approves the plans and specifications for the Sidewalk, Curb, and Gutter Repair Program FY 2019-20 SB1, Project No. PW1915.
- 3. The City Council awards a Construction Contract between the City of Stockton and FBD Vanguard Construction, Inc. in the amount of \$1,045,560, and the City Manager is authorized and directed to execute same, a copy of which is attached as Exhibit 2 and incorporated by this reference.

4. The City Manager is hereby authorized to take whatever actions are necessary and appropriate to carry out the purpose and intent of this Resolution.
