This Amendment Number 1 to the Agreement entered into on June 28, 2018 (the "MOU"), between the Animal Protection League, a California nonprofit public health corporation (the "APL"), and the City of Stockton, a municipal corporation (the "City").

RECITALS

The parties having entered into the MOU on June 28, 2018 for the APL to provide the City with certain services as set forth in the MOU; and

The terms of the Agreement, contained in Section 11.1 **Amendment**, state that no provision of the MOU may be amended or modified except by a written instrument signed by both Parties; and

The Appointees listed for both the APL and the City in Section 8.1 **Designees** are no longer employed by their respective agencies and, therefore, each party must provide an updated Appointee.

Now therefore, the APL and the City mutually agree as follows:

1. The term of the Agreement, contained in Section 8.1, is amended to read as follows:

"8.1. **Designees**. Each Party will appoint a person to serve as the official contact (each, a "**Designee**"). Each Designee shall have the authority to act on its respective Party's behalf in any matter relating to this MOU and shall be to whom formal notices and demands relating to this MOU are given. In addition, each Party will appoint a person to serve as the day-to-day coordinator for the activities of each Party in carrying out the terms of this MOU (each, an "**Appointee**"). Each Appointee shall have the authority to act on its respective Party's behalf in any matter relating to this MOU and shall be to whom communications relating to this MOU are given. SUBJECT: **AMENDMENT NO. 1 TO THE JUNE 2018 MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF STOCKTON AND THE ANIMAL PROTECTION LEAGUE FOR VETERINARIAN SERVICES**

A review of the June 2018 Memorandum of Understanding (MOU) between the City of Stockton (City) and the Animal Protection League (APL) for veterinarian services revealed that the designee for APL was incorrect. The designee on the 2018 MOU no longer is employed with APL. A further review of the MOU revealed that the appointees for the City and APL were outdated.

The Stockton Police Department (SPD) received guidance from Deputy City Attorney John Mulroy, who drafted the attached Standard Agreement Amendment No. 1. This Amendment provides the appropriate designees, appointees, and language, allowing for other persons "as appointed." APL has reviewed and signed Amendment No. 1.

It is the current intent of the SPD to exercise both one-year extensions as provided in the 2018 MOU, extending the service through Fiscal Year 2022/2023.
