## **RESOLUTION APPROVING THE FILING OF NOTICE OF EXEMPTION NO. NOE32-25, APPROVING THE PROJECT PLANS AND SPECIFICATIONS, AND AWARDING A \$144,130 CONSTRUCTION CONTRACT TO WEST VALLEY CONSTRUCTION COMPANY, INC. FOR THE CEDAR RIDGE WATER SERVICE LATERAL REPLACEMENT**

On July 3, 2025, the City Clerk of the City of Stockton opened, examined, and publicly declared the sealed bids offered for the Cedar Ridge Water Service Lateral Replacement; and

West Valley Construction Company, Inc. submitted the lowest bid in the amount of \$144,130; and

The bid submitted by West Valley Construction Company, Inc. is regular and responsive in all aspects; and

The replacement of water service laterals described in the proposed construction contract for the Cedar Ridge Water Service Lateral Replacement (Exhibit 3), the “project,” satisfies the 2040 Stockton General Plan (Land Use Policy 6.3) because it improves existing utility services to ensure that all neighborhoods have access to well-maintained public facilities and utilities that meet community service needs; and

The project is exempt from the California Environmental Quality Act (CEQA) requirements as specified under Article 19, section 15302, Class 2 (c), of CEQA Guidelines; now, therefore,

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:**

1. The filing of the Notice of Exemption No. NOE 32-25 under CEQA for the Cedar Ridge Water Service Lateral Replacement is hereby approved and staff are authorized to file and post it in compliance with CEQA Guidelines section 15062, a copy of which is attached as Exhibit 1 and incorporated by this reference.

2. The project Plans and Specifications for the Cedar Ridge Water Service Lateral Replacement are hereby approved, a copy of which is attached as Exhibit 2 and incorporated by this reference.

3. The City Manager is hereby authorized to execute a construction contract with West Valley Construction Company, Inc. of Campbell, California, in the amount of \$144,130 for the Cedar Ridge Water Service Lateral Replacement, a copy of which is attached as Exhibit 3 and incorporated by this reference.

4. The City Manager is hereby authorized to take appropriate and necessary actions to carry out the purpose and intent of this Resolution.
