RESOLUTION APPROVING THE NOTICE OF EXEMPTION NO. NOE 06-25, APPROVING THE PLANS AND SPECIFICATIONS, AND AWARDING A CONSTRUCTION CONTRACT FOR THE LED STREET LIGHTS CONVERSION, PHASES 7 AND 8, PROJECT NO. WD24017

On February 20, 2025, the City Clerk of the City of Stockton opened, examined, and publicly declared the sealed bids offered for the LED Street Lights Conversion, Phases 7 and 8, Project No. WD24017; and

The project will convert 1,785 high-pressure sodium residential streetlights primarily north of Hammer Lane to light-emitting diode luminaires; and

Bear Electrical Solutions, LLC is the second lowest responsive bidder in the amount of \$604,125, and its bid is regular in all respects; and

The project is in conformance with the City's General Plan, pursuant to California Government Code, section 65402, and is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) as specified under section 15301(c) of the CEQA Guidelines, because this is a discretionary project under the City's jurisdiction and qualifies as a project which has been determined to not have a significant effect on the environment; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

- 1. The City Council approves the filing of Notice of Exemption No. NOE 06-25 under the CEQA for the LED Street Lights Conversion, Phases 7 and 8, Project No. WD24017, a copy of which is attached as Exhibit 1 and incorporated by this reference.
- 2. The City Council approves the plans and specifications for the LED Street Lights Conversion, Phases 7 and 8, Project No. WD24017.
- 3. The City Council awards a Construction Contract between the City of Stockton and Bear Electrical Solutions, LLC, in the amount of \$604,125, and the City Manager is authorized and directed to execute same, a copy of which is attached as Exhibit 2 and incorporated by this reference.
