Biological Science/Physical and Life Science teaching credentials) and at the University of California, Davis (M.S. Hydrologic Science). I became involved with environmental issues specifically water quality and waste discharges after working for McCormick and Baxter Creosoting Company as a guality control chemist. I subsequently became a Registered Environmental Health Specialist and worked for San Joaquin County on contaminated site cleanups. I went back to school and earned a Master of Hydrologic Science degree from the University of California Davis from which I was recruited to work for a consulting firm. I found that I missed the teaching aspect of my graduate program. I began to use my teaching credentials that I earned many years before and have continued working in the field of education.
