RESOLUTION APPROPRIATING FUNDS, APPROVING THE NOTICE OF EXEMPTION NO. NOE50-24, APPROVING THE PLANS AND SPECIFICATIONS, AND AWARDING A CONSTRUCTION CONTRACT FOR THE HARDING WAY LEFT-TURN POCKETS, PROJECT NO. WT22046/STATE PROJECT NO. HSIPSL-5008(195)

On September 18, 2025, the City Clerk of the City of Stockton opened, examined, and publicly declared the sealed proposals or bids offered for the Harding Way Left-Turn Pockets, Project No. WT22046/State Project No. HSIPSL-5008(195); and

The project will install separate left-turn lanes, upgrade signals, and install high friction surface treatment at the intersections of Harding Way with Lincoln Street and with Pacific Avenue/Madison Avenue; and

Dirt Dynasty, Inc. is the lowest responsive bidder in the amount of \$1,519,552 and its bid is regular in all respects; and

The project is in conformance with the City's General Plan, pursuant to California Government Code, section 65402, and is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) as specified under section 15302 of the CEQA Guidelines, because this is a discretionary project under the City's jurisdiction and qualifies as a project which has been determined to not have a significant effect on the environment; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

- 1. The City Council authorizes the appropriation of State Highway Safety Improvement Program funds in the amount of \$146,340 to the Harding Way Left-Turn Pockets, Project No. WT22046/State Project No. HSIPSL-5008(195).
- 2. The City Council authorizes the appropriation of Public Facilities Fee Traffic Signal funds in the amount of \$452,000 to the Harding Way Left-Turn Pockets, Project No. WT22046/State Project No. HSIPSL-5008(195).
- 3. The City Council authorizes the appropriation of Public Facilities Fee Air Quality funds in the amount of \$260,167 to the Harding Way Left-Turn Pockets, Project No. WT22046/State Project No. HSIPSL-5008(195).
- 4. The City Council approves the filing of Notice of Exemption No. NOE50-24 under the CEQA for the Harding Way Left-Turn Pockets, Project No. WT22046/State

Project No. HSIPSL-5008(195), a copy of which is attached as Exhibit 1 and incorporated by this reference.

- 5. The City Council approves the plans and specifications for the Harding Way Left-Turn Pockets, Project No. WT22046/State Project No. HSIPSL-5008(195).
- 6. The City Council awards a Construction Contract between the City of Stockton and Dirt Dynasty, Inc., in the amount of \$1,519,552, and the City Manager is authorized and directed to execute same, a copy of which is attached as Exhibit 2 and incorporated by this reference.
- 7. The City Manager is hereby authorized to take whatever actions are necessary and appropriate to carry out the purpose and intent of this Resolution.
