# BACKGROUND



**State laws SB 946  
(2018)  
&  
SB 972 (2022)**



**These laws introduced new regulations, enforcement guidelines, and a new category of vendors, requiring updates to the SMC to ensure compliance and clarity.**



**May 13, 2025:**  
SPD presented proposed amendments to the SMC along with proposed fees and penalties.



**Council adopted ordinance 2025-12-16-1212.**  
**Next step is to conduct a Public Hearing to adopt new fee schedules.**

**December 16, 2025**  
SPD returned to City Council with updated municipal code amendments.

# NEW FEE SCHEDULE

- Introduces fees for violations and public property use to support enforcement and maintenance, ensuring vendors contribute to the costs of their operations.
- Fees are structured to deter repeat violations and promote responsible vending practices.

Public Property Use Fee	Pursuant to Stockton Municipal Code, Title 8, Chapter 8.70, Section 8.70.050, a fee to mitigate maintenance and repairs of Public Parks landscaping areas and features, irrigation systems, and other ancillary park facilities that may be damaged, disfigured, or destroyed, by street vendors and their clients' activities due to Public Parks not being originally intended, or designed, for such locations.	\$60.00
