## **CITY OF STOCKTON ASSEMBLY BILL 481 MILITARY EQUIPMENT USE**

Assembly Bill 481 established the following requirements to ensure the responsible use of military equipment for the safety of our community and our police officers





## **CITY OF STOCKTON ASSEMBLY BILL 481 MILITARY EQUIPMENT USE**

Requires Stockton Police Department to create a Military Equipment Use Policy (created April 2024 and revised July 2025)

### **Stockton Police Department Policy 706: Military Equipment**

- Military equipment includes, but is not limited to:
  - Unmanned, remotely piloted vehicles
  - Command and control vehicles
  - Noise-flash diversionary devices
  - Kinetic energy weapons and munitions
- All items in this policy are currently in use at the Stockton Police Department and have use policies in place.
- This policy is available to the public through the Stockton Police Department website.

City Council Approval for the use, funding, acquisition and continued use of already approved equipment.



The Stockton Police Department recognizes the public's ongoing interest in how military equipment is used to protect our community and our officers. We are committed to maintaining our community's trust in providing professional and responsive police services effectively and safely for all involved.

The term "military equipment" as used in Assembly Bill 481, does not necessarily indicate the equipment is, or has been used, by the military. Many items defined as "military equipment" by the bill are often used by law enforcement to preserve life and enhance public and officer safety while remaining prepared to handle the various challenges facing our communities. The Stockton Police Department's use of "military equipment" is consistent with overall best practices employed by the police departments throughout the country.

**Assembly Bill 481 establishes oversight for the responsible use, funding and acquisition of "military equipment."**

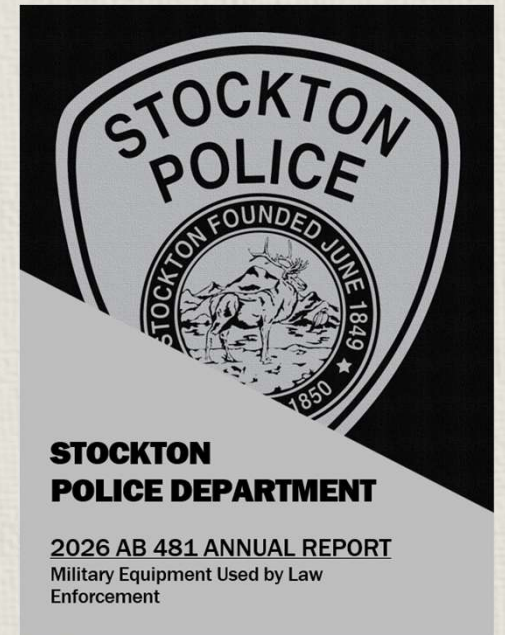

## Category 1 – Unmanned aerial or ground vehicles

Assembly Bill 481 Category 1 reporting requirements - Unmanned, remotely piloted, powered aerial or ground vehicles.



## Annual Report Summary

### CATEGORY 1 – Unmanned aerial or ground vehicles

The Stockton Police Department currently has 24 UAS (drones) in service and two EOD hazardous duty robots. These vehicles are used for search and rescue, tactical situations, and bomb defusal.

## Category 3 – Vehicles that have a breaching or entry apparatus attached

Assembly Bill 481 Category 3 reporting requirements - High mobility multipurpose wheeled vehicles (HMMWV), two and one-half-ton trucks, five-ton trucks, or wheeled vehicles that have a breaching or entry apparatus attached.



## Annual Report Summary

### CATEGORY 2 – Armored Personnel Carriers

### CATEGORY 3 – Vehicles that have a breaching or entry apparatus attached

The Stockton Police Department has two armored vehicles (one with breaching capabilities). These vehicles are used for emergency operations and provide officers and the public with a level of ballistic protection during critical incidents and rescues.

## Annual Report Summary

### CATEGORY 5 – Command and Control Vehicles

The Stockton Police Department has four Command and Control Vehicles.

- Two are dedicated as Mobile Command Posts and Crisis Negotiation vehicles.
- One is a Tactical Command Post for emergency response.
- One is a command vehicle for our Explosive Ordnance Disposal team.

### Category 5 – Command and control vehicles

Assembly Bill 481 Category 5 reporting requirements - Command and control vehicles that are either built or modified to facilitate the operational control and direction of public safety units.

## CATEGORY 7 - Battering Rams, Slugs, and Breaching Apparatuses Explosive in Nature

Assembly Bill 481 Category 7 reporting requirements -  
Battering rams, slugs, and breaching apparatuses that are  
explosive in nature.



## Annual Report Summary

### CATEGORY 7 – Battering Rams, Slugs, and Breaching Apparatuses Explosive in Nature

The Stockton Police Department is currently equipped with Breaching Slugs, Explosive Breaching Apparatuses, and Battering Rams. Each of these tools is utilized for extremely dangerous situations where failure to gain entry is not an option. The Breaching Slugs and Battering Ram of Explosive Nature will be utilized by both Patrol and the SWAT team.

## Category 12 – Flashbangs, explosive breaching, tear gas, pepper balls

Assembly Bill 481 Category 12 reporting requirements - "Flashbang" diversionary devices, explosive breaching tools, "tear gas" and "pepper balls", excluding handheld pepper spray.



## Annual Report Summary

CATEGORY 10 – Specialized firearms and ammunition of less than 50 caliber

CATEGORY 12 – Flashbangs, explosive breaching, tear gas, pepper balls

CATEGORY 14 – Kinetic energy weapons and munitions

The Stockton Police Department utilizes a variety of tools and equipment to safely respond to rapidly evolving critical incidents with the goal of a peaceful resolution and safety for all parties involved. These tools and equipment consist of, but are not limited to, less lethal munitions (bean bag rounds, 40 mm sponge rounds, tasers, etc.), patrol rifles, precision rifles, flashbangs, and chemical munitions. These tools are industry standard and commonly used by law enforcement across the nation. They provide capabilities and options while prioritizing the sanctity of life.



# CITY OF STOCKTON ASSEMBLY BILL 481 MILITARY EQUIPMENT USE

## Anticipated Acquisitions



EOD is anticipating the purchase of a new Bomb Squad Truck. The truck would be utilized as a Command and Control vehicle capable of immediate response and rendering devices safe. The anticipated cost is \$300,000.



The LRAD is a specialized loudspeaker used for communicating at a distance, negotiations with barricaded suspects, mass notifications, and natural emergencies.



# CITY OF STOCKTON ASSEMBLY BILL 481 MILITARY EQUIPMENT USE

## Anticipated Acquisitions

The Bearcat is utilized for preplanned operations, critical incidents, and rescues. We have had the original since 2012, and we are beginning to utilize it more on patrol.

The armor provides protection for us, which affords the opportunity for de-escalation and communication.



The "Rook" is an armored tracked vehicle. The protection and size of the vehicle allow for access to scenes not feasible by the Bearcat.



# CITY OF STOCKTON ASSEMBLY BILL 481 MILITARY EQUIPMENT USE

## Anticipated Acquisitions

The Stockton Police Department is anticipating acquiring a Command and Control vehicle to improve our ability to effectively respond to multiple negotiations and/or complex investigations occurring simultaneously.

The initial cost is approximately \$2,000,000 and the annual fiscal impact would be yearly maintenance.

## Anticipated Acquisitions

### Category 12 - Flashbangs, explosive breaching, tear gas, pepper balls

Assembly Bill 481 Category 12 reporting requirements - "Flashbang" diversionary devices, explosive breaching tools, "tear gas" and "pepper balls", excluding handheld pepper spray.



The Stockton Police Department is committed to training our staff to be professional by advancing their expertise with de-escalation, firearms, less lethal devices, and technology with the goal of reducing the use of force and providing great service to our community.



## **CITY OF STOCKTON ASSEMBLY BILL 481 MILITARY EQUIPMENT USE**

### **RECOMMENDED ACTION**

- Continue the use of the equipment currently used by the Stockton Police Department in accordance with the current policy.
- Approval for the acquisition of the LRAD (Long Range Acoustic Device), second Bearcat, Rook (armored tracked vehicle), Unmanned Aerial System (UAS), replacement of weapons and munitions/less lethal, Mobile Command Post Vehicle, and Explosive Ordnance Disposal (EOD) Response Vehicle.
