



# **PROJECT SCOPE**

- All funding distribution is subject to availability from California Opioid Settlement Agreements, and no funding is guaranteed.
- Funding up to the Not-to-Exceed amount will only be provided during the contractual term.
- Agreement is the second of anticipated initiatives for utilizing OSA funds during multi-year tranches.
- The City will continue to explore other Allowable Uses of Funds with additional community partners.



# **USE OF OPIOID SETTLEMENT FUNDS**

## High Impact Abatement Activities (HIAA)

- Support centralized call centers that provide information and connections to appropriate services and supports for persons with Opioid Use Disorder (OUD) and any cooccurring Substance Use Disorder/Mental Health (SUD/MH) conditions.
- ✓ Purchase automated versions of Screening, Brief Intervention, and Referral to Treatment (SBIRT) services, and support ongoing costs of the technology.
- ✓ Expand warm hand-off services to transition to recovery.







# RECOMMENDATION

- Approve findings pursuant to Stockton Municipal Code section 3.68.070 to justify and support an exception to the competitive bidding process.
- Award a Professional Services Contract to Care Solace, Inc. of Cardiff, CA in the Not-to-Exceed amount of \$855,000 for a three-year term, to provide social and mental health care coordination services utilizing funds received through the National Opioid Settlement Agreements.
- Authorize the City Manager to take appropriate actions to carry out the purpose and intent of this motion.
