Dear Mayor Lincoln II, Vice Mayor Warmsley and Council Members,

In the San Joaquin valley 22.8% of African Americans and 18.7% people living below the federal poverty level smoke cigarettes compared to 12.4% of the general population. Smoking is *still* the major cause of death—killing more people than alcohol, AIDS, car accidents, illegal drugs, murders, and suicides <u>combined</u>.

Requiring ALL retailers to be licensed with <u>No Exemptions</u>, closing loopholes in SB 793, placing buffer zones around schools, and limiting the density of tobacco retailer licenses with strict enforcement prevents youth access and helps those who use tobacco, to quit. Over 134 jurisdictions in 26 counties in California have already passed these types of policies. Local laws can have immediate impacts on improving the health of their residents.

Tobacco retailer licensing programs gives more local control to cities to monitor how retailers can sell tobacco and be able to afford to enforce local, state and federal laws. These programs ensure retailers are not selling products illegally. They provide strict guidelines that meet the needs of the community to address zoning and placement issues of new tobacco retailers near youth-serving and family-friendly sites like schools, parks, and youth centers. Including all retailers in the definition of a retailer makes for a level playing ground for all businesses and is a best practice.

Dear Mayor Lincoln, Vice Mayor Warmsley and City Council Members,

As a community member and volunteer on the STOPP Coalition, I commend you and your staff for working hard over the last several months to strengthen the proposed city ordinance that will require licensing of tobacco retailers. The changes you have made to require that **all** tobacco retailers obtain a city license, as well as requiring 600 feet distance between retailers and from youth-sensitive areas and ensuring licenses are non-transferrable make the Stockton ordinance much stronger and more effective. However, I and the STOPP coalition request that you consider the following additional requirements to strengthen the Ordinance even more:

- Ensure penalties are placed on the licensees and not clerks or customers
- Place a moratorium on any new licenses until the ordinance is implemented
- Conduct annual product inspections and annual compliance checks to ensure no illegal sales
- Close loopholes in SB793 by prohibiting the sale of all flavored tobacco products without exemptions (Option B).

A strong Tobacco Retail License (TRL) is a key tool to enforcement of laws pertaining to selling tobacco products to underage youth. By giving Stockton a strong tobacco control Ordinance you will protect the "health, safety and welfare of persons who reside in, work in and visit the City of Stockton" particularly our youth!

Dear Mayor Lincoln and Stockton City Councilmembers,

We are pleased that you are consider action to protect Stockton families from tobacco via the tobacco retail ordinance up for discussion tonight. There are several things we at the American Cancer Society Cancer Action Network (ACS CAN) like about this ordinance, which I've detailed in the attached letter. There are also some areas of concern where we recommend improvements.

## Areas of concern:

- They present multiple options for the council on flavors, none actually written into the ordinance so it's hard to weigh in when the language isn't there. We strongly urge Flavor OPTION B - a comprehensive end to all flavored tobacco with no exemptions.
- There is no explicit reference to compliance checks or youth decoy operations, we recommend one annual product inspection (checking for flavored tobacco, etc), and one annual youth decoy operation to check underage tobacco sales at all retailer
- Ordinance is effective in 90 days after adoption EXCEPT existing retailers can wait until their current business license expires before being required to get a TRL. This could be almost a year for a new business. We ask that all businesses that sell tobacco are required to obtain a TRL when the ordinance becomes effective.
- Although they have a breakdown of the fee, there's no explicit statement in the ordinance that the fee will be high enough to cover the cost of the program. We ask the fee be high enough to cover cost of license administration and enforcement.
- They list that retailers, employees or other can be charged with a misdemeanor for any violation of the ordinance, which we recommend against. This is a public health issue, not a criminal issue.

I will try to make it in person tonight to make public comment, along with a volunteer who lives in Stockton and shares our concerns.
