



## 2025 AMENDMENT OF SERVICES AGREEMENT

### City of Stockton, CA

This is the 2025 Amendment of the Original Services Agreement ("Agreement") dated September 28, 2017 by and between **CITY OF STOCKTON, A MUNICIPAL CORPORATION OF THE STATE OF CALIFORNIA** having its principal address at 605 N El Dorado Street, Stockton, CA, 95202 ("Customer," "Licensee," "you" or "your") and **RECTRAC, LLC d/b/a VERMONT SYSTEMS**, a Delaware limited liability company having its principal address at 12 Market Place, Essex Junction, VT 05452 ("VS," "Licensor," "we," "our," or "us") (each a "Party," and, collectively, the "Parties").
