**ADOPT A RESOLUTION TO ALLOCATE GRANT FUNDING FROM THE HOMELESS HOUSING, ASSISTANCE AND PREVENTION (HHAP) PROGRAM TO PERMANENT AND INTERIM HOUSING PROJECTS AND APPLY FOR, ACCEPT, AND APPROPRIATE GRANT FUNDING FROM HHAP ROUND SIX**

The State's HHAP funds are designed to support regionally coordinated efforts between the County, Continuum of Care (CoC), and the City to expand and develop local capacity to address immediate homelessness challenges throughout the state. HHAP funds are focused on moving homeless individuals and families into permanent housing and ensuring those individuals and families maintain their permanent housing.

Staff recommend that Council approve a resolution authorizing the allocation of HHAP funding to the 4 projects listed.

Staff further recommends Council authorize staff to apply for, accept, and appropriate HHAP 6. The HHAP grants are formula-based; however, the City is still required to apply for funds. Approval of this recommendation will position the City to apply for funds just made available in March through the NOFA application. In February staff received notifications of the possible award amount for HHAP 6 could be \$11,531,786.79 and must be applied in conjunction with San Joaquin County and is due in August 2025.



**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:**

1. Approve and allocate the following HHAP Round 3 and 4 recommendations for funding in the total of \$3.4 million, which includes the following 5 projects:
  - a) \$409,010 to Children's Home of Stockton for the Catalyst Project.
  - b) \$409,010 to Lutheran Social Services of Stockton for Project Hope.
  - c) \$409,010 to PREVAIL of Stockton for the Propel Project.
  - d) \$1,415,440 Delta Community Developers Corp. for Harding Way Apartments.
2. Authorizing staff to apply for, accept, and appropriate for Round 6 of the Homeless Housing, Assistance and Prevention Grant Program.

3. Authorize the City Manager, or designee, to enter into and execute any associated documents and take appropriate and necessary actions to carry out the purpose and intent of this resolution .
4. The City Manager is authorized to take such other actions as are appropriate to carry out the intent of this Resolution.
