**RESOLUTION APPROVING THE NOTICE OF EXEMPTION NO. NOE 04-25, APPROVING THE PLANS AND SPECIFICATIONS, AND AWARDING A CONSTRUCTION CONTRACT FOR THE LOCAL STREET RESURFACING PROGRAM FY 2024-25 SB1 – MILL AND OVERLAY, PROJECT NO. WD25003**

On February 13, 2025, the City Clerk of the City of Stockton opened, examined, and publicly declared the sealed proposals or bids offered for the Local Street Resurfacing Program FY 2024-25 SB1 – Mill and Overlay, Project No. WD25003; and

The project will apply a mill and overlay treatment to approximately one centerline mile of residential and collector roadways Citywide. The project includes removing and replacing pavement striping and legends, installation of Americans with Disabilities Act curb ramps, and the application of mill and overlay; and

Rapid Services, LLC dba Rapid Grading Services (Rapid Grading Services) is the lowest responsive bidder in the amount of \$1,215,000 and its bid is regular in all respects; and

The project is in conformance with the City's General Plan, pursuant to California Government Code, section 65402, and is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) as specified under section 15301(c) of the CEQA Guidelines, because this is a discretionary project under the City's jurisdiction and qualifies as project which has been determined to not have a significant effect on the environment; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The City Council approves the filing of Notice of Exemption No. NOE 04-25 under the CEQA for the Local Street Resurfacing Program FY 2024-25 SB1 – Mill and Overlay, Project No. WD25003, a copy of which is attached as Exhibit 1 and incorporated by this reference.

2. The City Council approves the plans and specifications for the Local Street Resurfacing Program FY 2024-25 SB1 – Mill and Overlay, Project No. WD25003.

3. The City Council awards a Construction Contract between the City of Stockton and Rapid Grading Services, in the amount of \$1,215,000, and the City Manager is authorized and directed to execute same, a copy of which is attached as Exhibit 2 and incorporated by this reference.
