RESOLUTION APPROPRIATING FUNDS, APPROVING THE NOTICE OF EXEMPTION NO. NOE51-23, APPROVING THE PLANS AND SPECIFICATIONS, AUTHORIZING PROFESSIONAL SERVICES CONTRACT AMENDMENT NO. 1, AND AWARDING A CONSTRUCTION CONTRACT FOR THE NORTH PERSHING AVENUE SAFETY ENHANCEMENTS, PROJECT NO. WT22047/STATE PROJECT NO. HSIPSL-5008(197)

On July 17, 2025, the City Clerk of the City of Stockton opened, examined, and publicly declared the sealed proposals or bids offered for the North Pershing Avenue Safety Enhancements, Project No. WT22047/State Project No. HSIPSL-5008(197); and

The project will improve safety at the intersections of North Pershing Avenue and Rosemarie Lane, and North Pershing Avenue and Country Club Boulevard. The project will add protected left turn signal phasing, lengthen existing turn pockets, and upgrade signal equipment; and

On August 19, 2022, the City Manager authorized a Professional Services Contract, in the amount of \$90,515, to CSG Consultants of Foster City, CA, for design services for the North Pershing Avenue Safety Enhancements, Project No. WT22047/State Project No. HSIPSL-5008(197); and

Appropriation of funding is needed for additional design services during construction; and

Quimu Contracting, Inc. is the lowest responsible bidder in the amount of \$586,595.20 and its bid is regular in all respects; and

The project is in conformance with the City's General Plan, pursuant to California Government Code, section 65402, and is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) as specified under section 15301(c) of the CEQA Guidelines, because this is a discretionary project under the City's jurisdiction and qualifies as a project which has been determined to not have a significant effect on the environment; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The City Council authorizes the appropriation of Highway Safety Improvement Program funds in the amount of \$75,600 to the North Pershing Avenue Safety Enhancements, Project No. WT22047/State Project No. HSIPSL-5008(197).

2. The City Council approves the filing of Notice of Exemption No. NOE51-23 under the CEQA for the North Pershing Avenue Safety Enhancements, Project No. WT22047/State Project No. HSIPSL-5008(197), a copy of which is attached as Exhibit 1 and incorporated by this reference.

3. The City Council approves the plans and specifications for the North Pershing Avenue Safety Enhancements, Project No. WT22047/State Project No. HSIPSL-5008(197).

4. The City Council authorizes Professional Services Contract Amendment No. 1, in the amount of \$18,880, with CSG Consultants for additional design services for the North Pershing Avenue Safety Enhancements, Project No. WT22047/State Project No. HSIPSL-5008(197), a copy of which is attached as Exhibit 2 and incorporated by this reference.

5. The City Council awards a Construction Contract between the City of Stockton and Quimu Contracting, Inc., in the amount of \$586,595.20, and the City Manager is authorized and directed to execute same, a copy of which is attached as Exhibit 3 and incorporated by this reference.

6. The City Manager is hereby authorized to take whatever actions are necessary and appropriate to carry out the purpose and intent of this Resolution.
