



### ADMINISTRATIVE HEARING CONCERNING ASSESSMENT OF DELINQUENT UTILITIES

#### DECLARATION OF ANGELA RODRIGUEZ

I, Angela Rodriguez, hereby declare as follows:

1. I am a Revenue Supervisor for the Administrative Services Department of the City of Stockton ("City") and have held this position since November 2024. Prior to that, I was an Office Specialist since January 2020 and a Revenue Collector since October 2010.
2. As a Revenue Supervisor for the City, I am responsible for annually compiling a list of delinquent utility accounts (the "Assessment List"), where that Assessment List will be considered by the City Council of the City of Stockton for transmission to the County of San Joaquin for collection via the property tax roll pursuant to the Stockton Municipal Code ("SMC") and applicable state statutes.
3. Those property owners who appear on the Assessment List are delinquent on one or more of the utilities provided directly by the City, which includes water (SMC Chapter 13.04), wastewater (SMC Chapter 13.12), and storm water (SMC Chapter 13.16).
4. On April 30, 2026, all property owners on the Assessment List were mailed, by certified mail, a "notice of Charges to be Assessed" concerning their delinquent utility amounts owed, which also indicated a date, time, and location to have their matter heard by an administrative hearing officer before their name was included in the Assessment List to be transmitted to the City Council. That opportunity to be heard was 8:30 AM in the City Council Chambers of the City of Stockton at 425 N El Dorado Street on Wednesday, May 13, Thursday, May 14, and Friday, May 22, 2026.

5. Aside from those property owners indicated by the City at the aforementioned hearings, the City received no written appeal statements from any property owners on or before the date and time of the aforementioned hearings.

If called as a witness in this matter, I could and would competently testify to the matters set forth above.
