We have settled in Stockton since. When I was studying English at San Joaquin Delta College, I actively involved in student government and got elected Vice President, then President of Student Government at Delta College. I also involved in the Asian American community in Stockton and within California and the U. S. I obtained my bachelor's degree in economics at the American University in Washington, DC and had completed all classes for the Master of Arts in Economics at the same school. I am currently working on a Master of Arts for Political Science at the California State University in Sacramento. I am currently President of the San Joaquin Chapter of the Asian Pacific American Public Affairs Association. We host candidate Forum, Townhall, and do voter registration and voter education for the Asian American community. The Asian American community in Stockton makes up 20% of the population and is growing. But our representation in the community is still not visible. We face challenges and concerns that have not been heard and addressed by the city. I feel the need to increase our representation in the city, and I am looking to be a voice for the Asian American community and Stockton community.

I have heard from the Asian American community about their pressing public safety concern. Many Asian American businesses experienced break-in, and they were afraid to report to the police. My house was burglarized once, and the police did not show up until the next day. People express that the city need to have more police patrol.
