RESOLUTION CERTIFYING THE RESULTS OF THE OPEN/PROMOTIONAL EXAMINATION FOR THE POSITION FIREFIGHTER TRAINEE / PARAMEDIC

The Chief Examiner for the Civil Service Commission opened the recruitment for FIREFIGHTER TRAINEE / PARAMEDIC on February 04, 2024, and closed it on February 29, 2024. The open/promotional recruitment evaluated applicants for specified knowledge, skills, and abilities to perform the duties of the Miscellaneous position of FIREFIGHTER TRAINEE / PARAMEDIC, as set forth in the job announcement prepared in accordance with the Rules and Regulations of this Commission; and

The Chief Examiner for the Civil Service Commission approved various open/promotional written examinations to be administered by the Firefighter Candidate Testing Center (FCTC) for FIREFIGHTER TRAINEE / PARAMEDIC between the dates of March 1, 2023, and February 29, 2024, and oral panel examinations were held the week of April 1, 2024, for the City of Stockton; and

The Chief Examiner has filed with this Commission a report of the results of the open/promotional examination, in accordance with Rule VI, Section 12(a) of the City of Stockton Civil Service Rules and Regulations for Miscellaneous Employees, which report is on file with the Human Resources Department; now, therefore,

BE IT RESOLVED BY THE CIVIL SERVICE COMMISSION OF THE CITY OF STOCKTON, AS FOLLOWS:

1. That the report of the open/promotional examination for the Miscellaneous position of FIREFIGHTER TRAINEE / PARAMEDIC is hereby approved.

2. That the open/promotional list of eligibles for the Miscellaneous position of FIREFIGHTER TRAINEE / PARAMEDIC for the City of Stockton, attached hereto as Exhibit 1, is hereby certified.

3. That the candidates appearing on Exhibit 1 are hereby declared eligible for appointment to the Miscellaneous position of FIREFIGHTER TRAINEE / PARAMEDIC and shall be certified to the appointing authority to fill vacancies approved by the Personnel Officer in accordance with the Stockton Municipal Code and the Rules and Regulations of this Commission.

4. That the list certified herein shall remain in effect for one (1) year and shall expire on April 18, 2025 unless the duration is otherwise changed by this Commission.
