This Amendment Number 2 to the above referenced Agreement is entered into on January 1, 2026; between the City of Stockton ("City") and Kyra Emanuels Ross ("Contractor").

## **RECITALS**

Exhibit C General Terms and Conditions, Paragraph 7 Changes, states the City may modify the scope of services and any material extension or change in the scope shall be memorialized in a written amendment prior to the performance of additional work; and

Exhibit C General Terms and Conditions, Paragraph 8 Amendment, states no variation of the terms of this Agreement shall be valid unless an Amendment is made in writing and signed by both parties; and

Exhibit A, Option to Renew, states both Parties may extend this Agreement up to December 31, 2026, however, the total term of the Agreement including the extended term shall not exceed 5 years; and

Exhibit A, Schedule of Compensation, states the annual compensation shall be increased by 3% for each one-year contract extension; and

The City needs to execute a second, one-year extension from January 1, 2026, to continue State Legislative Consulting and Advocacy Services through December 31, 2026.

Now therefore, the City and the Contractor mutually agree as follows:

- 1. The termination date in Paragraph 2 of the Standard Agreement is amended to: "December 31, 2026".
- 2. The one-year, not-to-exceed amount in Paragraph 3 of the Standard Agreement and Exhibit E, Section 2.1 is amended to \$114,888.00, which includes quarterly Fair Political Practices Commission (FPCC) registration and filing fees. The total maximum compensation to be paid to the Contractor under this Agreement for the initial term and the extended term, including quarterly FPPC filing fees, shall not exceed \$542,328.

All other terms and conditions of the Agreement shall remain unchanged and remain in full force and effect unless modified by a written amendment signed by both parties.
