APPENDIX C: DISCLOSURE CATEGORIES**

DISCLOSURE CATEGORY 1 – BROAD DISCLOSURE

- 1) All sources of income, gifts loans, and travel payments.
- 2) All investments and interests in real property within the boundaries of the City of Stockton, within a two-mile radius of any property owned or used by the City of Stockton, or subject to the jurisdiction of the City of Stockton
- 3) All investments and business positions in business entities

DISCLOSURE CATERGORY 2 – REAL PROPERTY

All interests in real property within the jurisdiction of the County, including interests in real property held by business entities and trusts in which a person in the designated position holds a business position or has an investment or other financial interest.

DISCLOSURE CATERGORY 3 – PROCUREMENT

All investments, business positions in business entities and sources of income, gifts, loans and travel payments from sources which provide services, supplies, materials, machinery, or equipment of the type utilized by the designated position's agency or department

DISCLOSURE CATEGORY 4 – REGULATING AND PERMITTING

All investments, business positions in business entities, and sources of income, gifts, loans, and travel payments from any source subject to the regulatory, permitting or licensing authority of, or which has an application or license pending before, the designated position's agency or department.

DISCLOSURE CATEGORY 5 – FUNDING

All investments, business positions and sources of income, gifts, loans and travel payments, from sources which receive grants or other funding from or through the designated position's agency or department.

DISCLOSURE CATEGORY 6 – LAND DEVELOPMENT

All investments, business positions and sources of income, gifts, loans and travel payments, from sources which engage in land development, construction, or real property acquisition or sale.

DISCLOSURE CATERGORY 7 – PROVISION OF SERVICES

All investments, business positions and sources of income, gifts, loans and travel payments, from any source that provides the same or similar service as the designated position's agency or department or provides consulting services to any source that provides the same or similar service.

DISCLOSURE CATEGORY 8: CONSULTANTS

Consultants (the individual representing the firm) shall be included in the listing of designated employees and shall disclose pursuant to Disclosure Category 1, subject to the following limitation: The City Manager may determine, in writing, that a particular consultant, although a "designated position," is hired to perform a range of duties that is limited in scope and, thus, is not required to fully comply with the disclosure requirements described in this section. Such written determination shall include a description of the consultant's duties, and based upon that description, a statement of the extent of disclosure requirements. The City Manager's determination is a public record, and shall be retained for public inspection in the same manner and location as this conflict of interest code.

Public Officials (Specified in Government Code Section 87200):

The positions listed below shall file a statement of economic interests pursuant to Government Code Section 87200. These positions are listed for informational purposes only.

1. Stockton City Councilmembers
2. City Manager
3. City Attorney
4. Chief Financial Officer
5. Stockton Planning Commissioners

An individual holding one of the above-listed positions may contact the Fair Political Practices Commission for assistance or written advice regarding their filing obligations if they believe that their position has been categorized incorrectly. The Fair Political Practices Commission makes the final determination whether a position is covered by Government Code section 87200.
