## **RESOLUTION AUTHORIZING THE ACCEPTANCE OF \$8,000,000 IN GRANT FUNDS FROM THE STATE OF CALIFORNIA, BOARD OF STATE AND COMMUNITY CORRECTIONS, UNDER THE SAFE NEIGHBORHOODS AND SCHOOLS ACT (PROPOSITION 47) – COHORT 5, FOR THE GRANT TERM OF OCTOBER 1, 2025, THROUGH JUNE 30, 2029, AND AUTHORIZING THE EXECUTION OF RELATED GRANT AGREEMENTS**

In June 2025, the City of Stockton's Office of Violence Prevention (OVP) applied for Proposition 47 funding through the Board of State and Community Corrections (BSCC). On September 11, 2025, the City was awarded \$8 million for a 45-month grant term (October 1, 2025 – June 30, 2029); and

With these funds, OVP and its county and community partners will launch the Restorative Engagement and Diversion through Incarceration Reduction, Care & Treatment (REDIRECT) Project. This initiative expands Stockton's violence reduction framework by providing behavioral health, substance use treatment, and supportive services for youth and adults at the highest risk of recidivism, incarceration, or violence; and

OVP will serve youth, families, and gang-impacted individuals, while Friends Outside will focus on transition-aged youth and adults. Services will prioritize individuals age 15 and older with Prop 47-eligible offenses, particularly those facing substance use, behavioral health needs, gang involvement, or housing instability. Severe cases will be referred to San Joaquin County Behavioral Health, while community partners provide case management and wraparound supports for mild-to-moderate needs; and

Participants will gain access to:

- Behavioral health and substance use treatment, including a 12-week relapse prevention curriculum;
- Employment readiness through the LEAP program with paid stipends, mentorship, and job placement;
- Housing supports, including transitional housing and emergency relocation;
- System navigation for transportation, IDs, benefits, and provider connections;
- Wellness programming to promote trauma recovery, relapse prevention, and nature-based healing; and

The REDIRECT Project aims to reduce recidivism, strengthen rehabilitation, and create pathways to stability for Stockton's most vulnerable residents; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. Authorize the City Manager to execute a grant agreement from the State of California Board of State Community Corrections, in the amount of \$8,000,000.
2. Authorize the City Manager to appropriate grant revenues and expenditures in the amount of \$8,000,000.
3. Authorize the allocation of three full-time grant-funded OVP staff, one outreach worker supervisor, and two outreach worker positions for the duration of the grant term.
4. The grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
5. Authorize the City Manager, or designee, to execute and manage contractor agreements and consultant agreements in the amounts consistent with the Grant Agreement.
6. The City Manager is hereby authorized to take appropriate and necessary actions to carry out the purpose and intent of this Resolution.
