



2022 AMENDMENT OF SERVICES AGREEMENT

This is the 2022 Amendment of the Original Services Agreement ("Agreement") dated September 28, 2017, by and between the **CITY OF STOCKTON, A MUNICIPAL CORPORATION OF THE STATE OF CALIFORNIA** having its principal address at 605 N El Dorado Street, Stockton, CA, 95202 ("Customer," "Licensee," "you" or "your") and **RECTRAC, LLC d/b/a VERMONT SYSTEMS**, a Delaware limited liability company having its principal address at 12 Market Place, Essex Junction, VT 05452 ("VS," "Licensor," "we," "our," or "us") (each a "Party," and, collectively, the "Parties").

The Customer and VS hereto desire to amend the Agreement in order to exercise the Customer's option to renew the contract for five(5) years, as well as to amend the total cost of the Agreement.

Term of Agreement: Five Years – September 20, 2022, through September 20, 2027, and subsequent options to renew annually.


