**RESOLUTION APPROVING THE NOTICE OF EXEMPTION NO. NOE10-22, APPROVING THE PLANS AND SPECIFICATIONS, APPROPRIATING FUNDING, AND AWARDING A CONSTRUCTION CONTRACT FOR THE HSIP 9 - INSTALL SIDEWALK AND MEDIAN FENCING ALONG DR. MARTIN LUTHER KING JR. BOULEVARD, PROJECT NO. WT19003/FEDERAL PROJECT NO. HSIPL-5008(186)**

On November 3, 2022, the City Clerk of the City of Stockton opened, examined, and publicly declared the sealed proposals or bids offered for the HSIP 9 - Install Sidewalk and Median Fencing Along Dr. Martin Luther King Jr. Boulevard, Project No. WT19003/Federal Project No. HSIPL-5008(186); and

The installation of median fencing along Dr. Martin Luther King Jr. Boulevard will improve pedestrian safety by preventing jay walking and unsafe mid-block crossing. The project will include adding guardrail, signage, pavement markings, safety lighting, and replacing curb ramps; and

United Pavement Maintenance, Inc. is the lowest responsible bidder in the amount of \$538,159.85, and its bid is regular in all respects; and

Caltrans National Environmental Policy Act determination was received on October 19, 2018. The State determined that the project is a Categorical Exclusion under 23 CFR 771.117(c): activity (c)(26). Similarly, the project is in conformance with the City's General Plan, pursuant to California Government Code, section 65402; and

The project is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) as specified under section 15301(a) of the CEQA Guidelines, because this is a discretionary project under the City's jurisdiction and qualifies as a project which has been determined to not have a significant effect on the environment; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. The City Council approves the filing of Notice of Exemption No. NOE10-22 under the CEQA for the HSIP 9 - Install Sidewalk and Median Fencing Along Dr. Martin Luther King Jr. Boulevard, Project No. WT19003 (formerly PW1903)/Federal Project No. HSIPL-5008(186), a copy of which is attached as Exhibit 1 and incorporated by this reference.

2. The City Council approves the plans and specifications for the HSIP 9 - Install Sidewalk and Median Fencing Along Dr. Martin Luther King Jr. Boulevard, Project No. WT19003 (formerly PW1903)/Federal Project No. HSIPL-5008(186).

3. The City Council approves the appropriation of funds in the amount of \$11,000.00 from the Measure K Maintenance Fund Balance to the HSIP 9 - Install Sidewalk and Median Fencing Along Dr. Martin Luther King Jr. Boulevard, Project No. WT19003 (formerly PW1903)/Federal Project No. HSIPL-5008(186).

4. The City Council approves the appropriation of funds in the amount of \$97,470.00 from the Highway Safety Improvement Program to the HSIP 9 - Install Sidewalk and Median Fencing Along Dr. Martin Luther King Jr. Boulevard, Project No. WT19003 (formerly PW1903)/Federal Project No. HSIPL-5008(186).

5. The City Council awards a Construction Contract between the City of Stockton and United Pavement Maintenance, Inc. in the amount of \$538,159.85, and the City Manager is authorized and directed to execute same, a copy of which is attached as Exhibit 2 and incorporated by this reference.

6. The City Manager is hereby authorized to take whatever actions are necessary and appropriate to carry out the purpose and intent of this Resolution.
