## **RESOLUTION DECLARING ELECTION RESULTS OF PRIMARY MUNICIPAL ELECTION OF MARCH 7, 2000**

WHEREAS, a Primary Municipal Election was consolidated with the State of California Primary Election held on March 7, 2000, pursuant to Stockton City Charter Article VII; and

WHEREAS, the San Joaquin County Registrar of Voters ("Registrar") was authorized to canvass the returns of the election pursuant to an agreement between the City of Stockton and the County of San Joaquin entered into on December 14, 1999; and

WHEREAS, the Registrar has conducted the canvass and stated the results in the "Certificate of Results of the City of Stockton Municipal Election Held on March 7, 2000"; and

WHEREAS, California Elections Code sections 10262 and 10264 require the adoption of a resolution reciting the fact of the election and a statement of the results; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. That the whole number of votes cast in the City of Stockton was 44,638 as confirmed by the Registrar.

2. The names of the persons voted for, the offices for which they were voted, and the total number of votes given in the City to each person are as set forth in the Certificate of Results prepared by the Registrar, dated March 27, 2000, attached hereto as Exhibit "A" and incorporated herein.

3. That the number of votes given at each precinct to each person is as set forth in an excerpt from the Statement of Votes prepared by the Registrar, dated March 26, 2000, attached hereto as Exhibit "B" and incorporated herein.

4. That GARY A. PODESTO, being the sole candidate for the office of Mayor and receiving a majority vote is hereby declared MAYOR-ELECT (at large) for a term commencing January 1, 2001, and terminating December 31, 2004.

5. That RICHARD F. NICKERSON and JOHN "JACK" LAVEN received the greatest number of votes for the office of COUNCILMEMBER from DISTRICT 2 and are hereby declared the candidates for said district who will proceed to the City-wide November 7, 2000, General Municipal Election.

6. That FRANK "LARRY" RUHSTALLER and SUKH S. CHAHAL received the greatest number of votes for the office of COUNCILMEMBER from DISTRICT 4 and are hereby declared the candidates for said district who will proceed to the City-wide November 7, 2000, General Municipal Election.

7. That GLORIA C. NOMURA and RALPH L. WHITE received the greatest number of votes for the office of COUNCILMEMBER from DISTRICT 6 and are hereby declared the candidates for said district who will proceed to the City-wide November 7, 2000, General Municipal Election.


