

#### April 2023

- Easter Egg Hunt at Micke Grove Park- San Joaquin County Parks and Recreation hosted its annual Easter Egg Hunt on Saturday, April 1, 2023. It was a huge success with over 10,000 eggs distributed, bounce houses, food trucks and multiple children's activities. It was a beautiful day with about 2,000 attendees.
- Easter Sunday-As the beautiful weather continued the following weekend, Easter Sunday at
  Micke Grove Regional Park and Oak Grove Regional Park had its highest single day attendance
  since COVID-19, requiring the Parks to limit or close the entrance for a couple of hours as the
  parks reached capacity.
- River Sites- Due to extremely high flows, river access to the Mokelumne and the San Joaquin Rivers remains closed which includes the Mossdale Landing and Dos Reis boat launches. In addition to high water levels, some ground flooding still remains at Dos Reis Day use area and campground, Westgate Landing day use and campground, and Stillman Magee Day use and campground which also remain closed.
