

## **ORDINANCE NO.**

**AN ORDINANCE AMENDING TITLE 2, CHAPTER 2.08, SECTIONS 2.08.010, 2.08.030, 2.08.040, AND 2.08.060 OF THE STOCKTON MUNICIPAL CODE TO SET THE SALARY AND BENEFITS FOR THE MAYOR AND CITY COUNCIL OF THE CITY OF STOCKTON FOR THE PERIOD BEGINNING JANUARY 1, 2025**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF STOCKTON AS FOLLOWS:**

### **SECTION I. AMENDMENT OF CODE**

Title 2, Chapter 2.08, Section 2.08.010 is hereby amended to read as follows:

#### **2.08.010 Salary of Mayor.**

The annual salary of the Mayor shall be \$97,107 (\$8,092.24 / monthly) payable on the payment schedule for City employees.

### **SECTION II. AMENDMENT OF CODE**

Title 2, Chapter 2.08, Section 2.08.030 is hereby amended to read as follows:

#### **2.08.030 Effective date of salary and benefits of Mayor.**

The salary and benefits of the Mayor shall be effective on January 1, 2025.

### **SECTION III. AMENDMENT OF CODE**

Title 2, Chapter 2.08, Section 2.08.040 is hereby amended to read as follows:

#### **2.08.040 Salary of City Councilmembers.**

The annual salary of each member of the City Council, except the Mayor, shall be \$30,832.62 (\$2,569.40 / monthly) payable on the payment schedule for City employees.

### **SECTION IV. AMENDMENT OF CODE**

Title 2, Chapter 2.08, Section 2.08.060 is hereby amended to read as follows:

#### **2.08.060 Effective date of salary and benefits of City Councilmembers.**

The salary and benefits of each member of the City Council, except the Mayor, shall be effective on January 1, 2025.

## **SECTION V. SEVERABILITY**

If any provision of this ordinance or the application thereof to any person or circumstance is held invalid, that invalidity shall not affect other provisions or applications of the act which can be given without the invalid provision or application, and to this end the provisions of this act are severable.

## **SECTION VI. EFFECTIVE DATE**

This ordinance shall take effect and be in full force thirty (30) days after its passage.
